

Limitations

»Size: Maximum 36”W x 48”H and not smaller than 20”W x 26”H outside frame dimensions.

»All work must be framed and ready to hang with strong wire and flat metal hangers.

Liability

»All reasonable care will be taken with paintings and submissions. NPS, its officers, volunteers, and the American Art Company shall not be held responsible for the loss and damage to paintings, frames, or digital entries.

»NPS suggests that participants carry separate insurance as provided under individual contracts with shippers and receiving agents.

»The artist grants permission to reproduce work for show publicity and/or catalog purposes. Copyright will be attributed to the artist. Entry into this exhibition constitutes agreement with all conditions set forth in this prospectus and Entry Form, and is your commitment to participate.

Your entry form is a legal and binding contract to deliver artwork that has been juried into the show. If, after being juried in, an entrant chooses not to deliver artwork, he or she may not enter an NPS show for a period of two years.

Submission of entries

»No more than 3 digital images (emailed or sent on a cd) per artist will be accepted. Entry fees will not be refunded.

»Download your images into photo finishing software such as Photoshop Elements. Then, using photo editing software, resize the images to 1200H x 1800W pixels or 4”H x 6”W.

Height may vary, but width should always be 1800 pixels (6”) at a resolution of 300 dpi. This ensures that an (approximately) 4 x 6, high-resolution image of your painting can be reproduced in NPS postcards, catalogs and other print media.

»Save each of your jpg images using this convention: “yourlastname.titleofpainting.sizeofpainting.jpg” No spaces or symbols in name.

Digital entry jpegs should be emailed (each image in a separate email) to pennychadwell@mac.com. Please use “NPS International Exhibit entry” in the subject line. You may also burn your images to a cd and send it via regular mail. All entries must be postmarked by April 18, 2008.

Entry forms and checks (and image cds, if applicable) should be mailed to: Penny Chadwell, 1574 Sudden Valley, Bellingham, WA 98229, along with a #10 self-addressed, stamped envelope (SASE).

Sales

All work must be for sale and realistically priced. A 50% commission will be taken by American Art Company. The gallery will pay the artist two weeks after the show closes.

Eligible work

Artist must be 18 years of age or older. All work must be original in concept and executed by the artist in the pastel medium within the last two years. Work exhibited in previous NPS exhibits is not eligible. No instructor assisted (hands on) work is eligible. Mixed media pieces must be 85% predominately pure pigment pastel.

Delivery of accepted work

You will receive all necessary papers in the jury notification packet, including a copy of our shipping agent’s (Phoenix) shipping instructions specifications. Works may be hand carried to the gallery or shipped or hand carried to Phoenix Restoration & Custom Framing, 17521 15th Ave., Shoreline, WA 98155.
